Clarifying a few points

To the Editor:

As an employment rights attorney, it was an honor to be selected as one of the New Hampshire workers highlighted in The Sunday Telegraph's Sept. 4 article on Labor Day. I would like to correct a couple of points left muddy by the editing.

First, in discussing employment discrimination cases, an employee can do a lot if discriminated against on the basis of age, sex, national origin, race, religion, physical or mental handicap.

To preserve anti-discrimination rights under state and federal laws, the employee should contact the N.H. Commission for Human Rights at (603) 271-2767 promptly upon learning of the discriminatory act. There is no cost and there is no need to retain an attorney. Failure to file within strict time limits may result in the loss of important legal rights.

Whistleblower complaints should be reported to the N.H. Department of Labor (800-272-4353). Union activity protection is enforced by the Public Employee Labor Relations Board (271-2587). Other employment rights, like breach of contract and wrongful termination, have three-year statutes of limitation which are enforced in court.

Secondly, while both sets of my grandparents were immigrants who labored long and hard, my parents were born and raised in New England. Imbued with the importance and value of work and of workers, my parents were leaders of employees' rights.

My mother, a registered nurse, suffered professional retribution when she led the fight to unionize a major Maine hospital. My father, a corporate executive at a small Maine shoe company, spoke out against unfair employment practices brought on by a corporate merger.

Their efforts on behalf of their fellow employees, and their courage in the face of their employers' retaliation, continue to inspire me.
